

## **Clinical Policy: Cosyntropin (Cortrosyn)**

### **Description**

Cosyntropin (Cortrosyn<sup>®</sup>) is a synthetic subunit of adrenocorticotrophic hormone.

### **FDA Approved Indication(s)**

Cortrosyn is indicated for use as a diagnostic agent in the screening of patients presumed to have adrenocortical insufficiency.

### **Policy/Criteria**

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.*

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Cortrosyn is **medically necessary** when the following criteria are met:

## **I. Initial Approval Criteria**

### **A. Presumed Adrenocortical Insufficiency (must meet all):**

1. Prescribed for diagnostic testing of adrenocortical insufficiency;
2. Dose does not exceed one of the following (a or b):
  - a. If age  $\leq$  2 years: 0.25 mg per dose (1 vial);
  - b. If age  $>$  2 years: 0.75 mg per dose (3 vials).

**Approval duration: 1 dose**

### **B. Other diagnoses/indications**

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace and CP.PMN.53 for Medicaid.

## **II. Continued Therapy**

### **A. Presumed Adrenocortical Insufficiency**

1. Re-authorization is not permitted. Members must meet the initial approval criteria.

**Approval duration: Not applicable**

### **B. Other diagnoses/indications (must meet 1 or 2):**

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

**Approval duration: Duration of request or 3 months (whichever is less); or**

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace and CP.PMN.53 for Medicaid.

#### III. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policy – HIM.PHAR.21 for health insurance marketplace and CP.PMN.53 for Medicaid or evidence of coverage documents.

Diagnostic testing of adrenal insufficiency	0.25-0.75 mg IV or IM; in pediatric patients $\leq 2$ years, 0.125 mg will often suffice	0.75 mg/dose
